CALL FOR TENDERS NGAPD-2006 ADDENDUM N° 1

Call for Tenders: NGAPD-2006

Scope: "Kardia Mine Pumped Hydro Storage: Early Technology Provider Involvement for Design, Supply, Erection and Commissioning of Pump, Turbine, Generator and Auxiliary Systems"

By means of the present Addendum N° 1, the following modifications and/or clarifications are hereby introduced and incorporated into the Call for Tenders NGAPD-2006:

a. Amendments to Clause 3.5 "Eligibility Criteria"

- i. Point 1 of Clause 3.5 "Eligibility Criteria" of the Call for Tenders NGAPD-2006, is hereby entirely superseded and replaced with the following:
 - 1. The Tenderer shall provide evidence demonstrating having successfully completed the hydraulic and mechanical design, model testing, manufacturing, supply, and commissioning of reversible pump/turbine for at least one project within the European Union of more than 70 MW per unit and between 90 to 450 meters water head commissioned in the last 10 years, or at least three projects within the European Union of more than 70 MW per unit and between 90 to 450 meters water head commissioned in the last 20 years.
- ii. Point 2 of Clause 3.5 "Eligibility Criteria" of the Call for Tenders NGAPD-2006, is hereby entirely superseded and replaced with the following:
 - 2. The Tenderer shall provide evidence demonstrating having successfully completed the mechanical and electrical basic and detailed design, supply, and commissioning of generator/motor for at least one project within the European Union of more than 80 MVA per unit for a project between 90 and 450 meters water head commissioned in the last 10 years, or at least three projects of more than 80 MVA per unit for projects between 90 and 450 meters water head commissioned in the last 20 years.
- iii. The turnover requirement stated in Point 4 of Clause 3.5 "Eligibility Criteria" of the Call for Tenders NGAPD-2006, is hereby amended as follows:
 - 4. The Tenderers' Annual Turnover shall be higher than **one hundred fifty million (150,000,000) Euros** for each of the last three financial years.
- b. Amendment to Clause 5.1 "Contract for Lot 1 Project Execution", last section

The last section of Clause 5.1 ""Contract for Lot 1 Project Execution" of the Call for Tenders NGAPD-2006, initially reading:

"The final value of the Lot 1 Contract will be based on the above starting point as reasonably adapted due to any evolution in the design, specifications, division of works and battery limits that will have been mutually agreed at the end of the Early Engineering Contract."



is entirely superseded and replaced with:

"The final value of the Lot 1 Contract will be based on the above starting point and shall be reasonably adapted in order to reflect any mutually agreed evolution in a) the design, b) the technical specifications, c) the division of works and battery limits, or d) the Heads of Terms, that have occurred during the course of the Early Engineering Contract."

c. Revised Tenderer Declaration

In view of the fact that the original template of the "Tenderer Declaration" included in Annex IV of the Call for Tenders No. NGAPD-2006 did not account for the possibility of submitting deviations—despite such deviations being permitted under the terms of the Call for Tenders—the said Declaration has been revised accordingly. The updated version also reflects any clarifications issued or to be issued to Tenderers during the pre-submission clarification process, as well as any Addenda issued to the Call for Tenders.

The revised "Tenderer Declaration" is attached herewith and shall be used as-is for the purposes of submissions under the Call for Tenders No. NGAPD-2006.

d. APPENDIX C to ANNEX II

APPENDIX C, titled "GTS (GENERAL TECHNICAL SPECIFICATIONS)", to ANNEX II ("TECHNICAL PART") of the Call for Tenders No. NGAPD-2006, was inadvertently omitted from the originally published version of the Call for Tenders. The aforementioned APPENDIX is hereby attached and shall be deemed an integral part of ANNEX II and of the Call for Tenders No. NGAPD-2006 as a whole.

All other terms and conditions of the Call for Tenders shall remain as previously written and in full force and effect, except to the extent expressly modified by the present Addendum N° 1.
